

My Home Value & Property Intelligence Addendum to MSA

The provision of My Home Value and Property Intelligence by Company to Client pursuant to the My Home Value and Property Intelligence terms and conditions set forth below (the **"My Home Value Terms"**) shall be subject to the terms and conditions of the Master Services Agreement between Company and Client that governs the provision of the Platform and Platform Services (the **"MSA"**) and any applicable Order. If these My Home Value Terms and the terms of the MSA or Order conflict or are inconsistent, these My Home Value Terms shall govern and control strictly as it relates to the provision of My Home Value provided by Company.

1. My Home Value Terms

- a. These My Home Value terms apply to My Home Value and Property Intelligence products and services provided to Client (referred to herein collectively as the **"My Home Value Services"**). These My Home Value Terms form a contract (the **"Addendum"**) that governs the relationship between Array US Inc. and its Affiliates (referred to herein as **"us"** or **"our"**) with any individual including Subscribers, or businesses (referred to herein as **"you"** or **"Client"**) that accesses, uses, requests, or receives the My Home Value Services.
- b. Our privacy policy located at <https://array.com/legal/#privacy> (the **"Privacy Policy"**) describes how we collect and use personal and non-personal information when you request the My Home Value Services, and should be read together with the MSA, applicable Order, and this Addendum. By using the My Home Value Services, you are agreeing that we may use information collected through the My Home Value Services in accordance with the Privacy Policy.
- c. The Services are made available to you only on the condition that you agree to be bound by the current My Home Value Terms, including all restrictions provided herein. If you do not agree, do not access or use the My Home Value Services. The following apply to access to, and use of, the My Home Value Services:
 - i. You may only use the My Home Value Services in compliance with these My Home Value Terms and all Applicable Laws, rules, and regulations;
 - ii. If you reside in a jurisdiction that restricts the use of internet-based applications or the ability to enter into contracts such as this Addendum according to age or for any other reason, and you are under such age limit or subject to such other restriction, you are not permitted to use the My Home Value Services;
 - iii. By using the My Home Value Services, you are representing that you have the legal capacity and authority to enter into this Addendum, and that you have reviewed, understand, and accept this Addendum without limitation or qualification;
 - iv. If you are accepting this Addendum on behalf of a company, organization, or other legal entity, you represent and warrant that you are authorized to do so; and
 - v. You further understand that by selecting My Home Value Services for purchase and entering personal information where prompted, you are submitting an electronic signature and entering into a legally binding contract with us for the purchase of such My Home Value Services.
- d. We may modify the Addendum or MSA from time to time by notifying you of such modifications by any reasonable means as specified in the MSA. Your continued use of the My Home Value Services after any such changes indicates your acceptance of the modifications. Note that any such modifications will not apply retroactively to any dispute between you and us arising prior to the date on which we posted the revisions or otherwise notified you of the changes.

2. Services Description.

- a. The My Home Value Services include a dashboard to estimate a Subscriber's or consumer's estimated home value, accrued equity, and mortgage balances for educational purposes. The My Home Value Services may also include the presentation of other home-related offers, resources, and services. We reserve the right to determine and modify the My Home Value Services we offer in our sole discretion.

The My Home Value Services are provided for general information purposes only, and are not intended to, and do not, constitute legal, professional, or financial advice, and may not be used for such purposes. - c. This Addendum, including the MSA and any applicable Order, constitutes the entire agreement between you and us regarding the My Home Value Services and supersedes any prior agreements between you and us and any and all prior or contemporaneous statements, understandings, writings, commitments, or representations concerning its subject matter. This Addendum can only be amended by us, as provided in this Addendum or the MSA. No written or verbal statement, advertisement, or product description will contradict, interpret, or supplement this Addendum.
